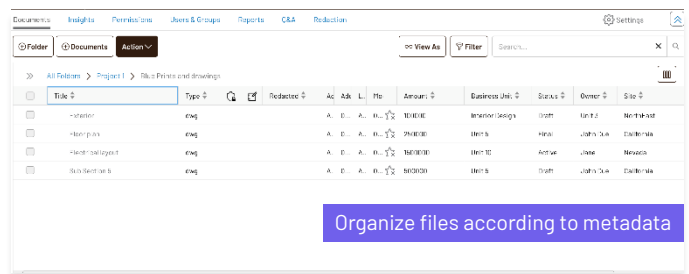
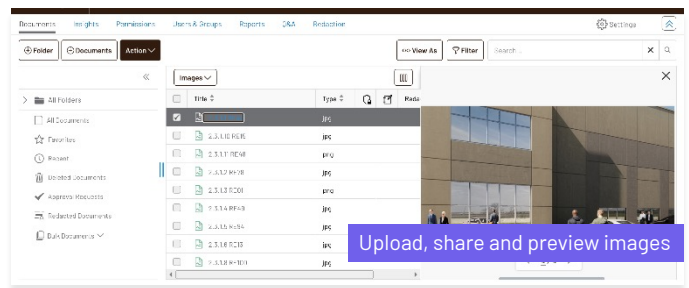
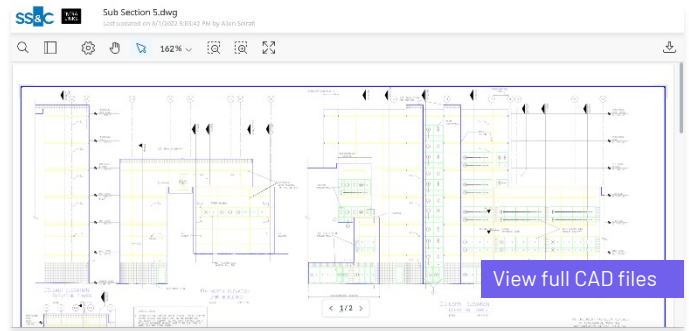

- **IRM/UNshare:** Protect sensitive data and retain the ability to recall a document even if a collaborator has already downloaded it.
